OPC recorder software installation

WARNING: Before installing the software check compatibility with the minimum hardware and software requirements.

Before launching the software installation procedure enable the features. NET Framework 2.0, . NET Framework 3.0 e. NET Framework 3.5 in the Windows feature menu.

Start the installation of the OPC Recorder software through the setup (setup.exe) downloaded exclusively from the official website www.odeca.it. The setup installer installs all software prerequisites if the target machine is compatible.

Start the installation from the OPC_Standalone.msi installer only if all software prerequisites are already met.

In order to complete the installation process you must read and accept the license agreement (EULA) of the software found at the bottom of this manual.


If the license agreement is not accepted, the installation will be interrupted and the installer will be closed.

Following acceptance of the contract, the installation folder of the OPC Recorder software can be set.

The default installation folder is:

C:\Program Files (x86)\Odeca srl\PC Recorder\

During the application setup you can choose whether to install the program for all Windows users or only for the current user.



Software attivation

At the first start of the software you will be asked to enter a license key.

The license code is strictly related to the machine hardware identifier, it cannot be used to activate multiple copies of the same software.

The activation code is provided exclusively by Odeca S.R.L. or an authorized reseller.

The software can be activated temporarily through a temporary license code of maximum 30 days. The temporary license is provided exclusively by Odeca S.R.L. or an authorized reseller.

If the activation code used is temporary, the activation window will be displayed every time the application starts.




Software description

PC Recorder software is divided into 3 application areas:


- An Odeca PC Recorder Service (A service) that manages communication between your computer and Odeca balances over an Ethernet network.
- An application manager (OPCR Manager) responsible for configuring balances and storage settings.
- A client application (OPCR Client) used to view the recorded weighing.

If the automatic execution of the Odeca PC Recorder Service is enabled, the service will start automatically when the computer starts, you do not need to login with your Windows user to start weighing recording.




Odeca scale settings

To set up the communication between the OPCR Service and the Odeca scales, it is necessary to set each balance via the Manager application.



The appropriate button opens the relevant window where you can specify a Description of the balance itself (by default Balance 1, Balance 2...), the unit of measurement choosing between Kilograms and Grams and the IP address (or DNS)



Odeca balances must be connected to the same network as the computer on which the software is installed and the communication protocol must be set to "Request" on each weighing instrument.

To start the communication between the service and the tools you need to set the status of the communication to "ACTIVE".

Communication between the service and the tools can be:



- **ACTIVE**: TCP communication and weighing storage is active. If the balance is not reachable, the service takes over the connection.
- **PAUSE**: the TCP connection is active but the storage of the weighs is suspended. If the balance is not reachable, the service takes over the connection.
- **DISABLE**: No connection is made and the network resources of the weighing instrument are released.


Database settings

The PC Recorder application relies on SQL Local DB databases, however you can choose to use a shared Microsoft SQL database to make stored data accessible from other locations.



To access the software's storage settings you need to right-click on the program icon in the notifications area of the start bar then select Storage Settings...

By selecting storage settings, the Manager application automatically searches for reachable Microsoft SQL servers.



If the shared database usage checkbox is activated, the information required to connect to the DB instance will be asked otherwise the localdb service installed during the program setup will be used.

If the direct file export checkbox is activated, the weighings will be written to the set file (as well as to the local or shared DB).

The decimal separator can be set as **Dot** or (default) **Comma**, this will be used at the time of weighing recording.

Weight management


The Odeca PC Recorder Client program allows you to view the recorded weighing.

The weighing list must be updated manually via the refresh button located in the menu at the top of the main screen.

Stored transactions can be filtered through a range of dates, servers, balances, and codes associated with the transactions.

The total printed and viewable at the bottom of the main screen refers to the only weightings displayed: it is calculated taking into account the filters set.

The printing and export operations to files are referred to filtered weighing only: only the transactions displayed can be exported or printable. The export can be done on Excel files (XLS and XLSX), CSV or TXT text files.



Client software settings allow you to

- Change the interface theme by choosing between light or dark depending on your needs or preferences.
- Choose the printer to use for printing reports from all available printers.
- Rename the free fields Code 1 and Code 2 as you need.
- Change Database settings.
- Select which fields to make visible when browsing stored transactions.

Transaction table

If you use a shared Microsoft SQL Server database, the related transaction table (Transactions) is populated by the OPCR Service while the OPCR Service records the weighing.

The Transactions table provides access to information such as:
